St. Patrick's Day Parade Rules and Regulations

MUST SIGN AND RETURN COPY WITH YOUR ENTRY. — Entry is not complete without this!!

EVERYONE in your unit must know & abide by these rules!

PARTICIPATION

1. The number of entries allowed in the Parade is limited. All decisions of the Organizing committee are final.
2. Bands/Marching Units. Units other than official Marching Bands are limited to 35 marchers. Children 5 & under may not march but may ride. It's too far for the wee ones to march!
3. Car & Motorcycle Clubs: Due to space limitations, each club is limited to no more than **eight (8)** vehicles. All drivers must be 16 or older & licensed. **There is a limit of ten car clubs & two motorcycle clubs in the Parade.**
4. Floats. Unit may not be taller than 13'4", wider than 8'6", length limit is 65 feet.
5. Political Entries. Continuing the tradition of the Parade, political candidates are allowed. Signage is limited to 1 lead banner and 2 campaign signs no larger than 3' x 3'.
6. Banners & Signage. Each Unit is limited to one "lead" banner and two "Sponsor" signs. Paper handouts are discouraged.
7. No throwing of candy or other items into the crowd. Someone may walk along side the unit & hand out such items. However, no one may jump on & off of moving vehicles to hand out candy. Drivers who allow throwing of objects & riders jumping on & off will be ticketed by CSPD.
8. Insurance Certificate. Entries with motorized vehicles and/or livestock must submit a Certificate of Insurance showing that they have liability insurance as provided by Colorado law.
9. Decoration of Entry: **ALL** entries must be decorated and pertain to "St. Patrick's Day" — lots of green, shamrocks, leprechauns, 4-leaf clovers, more green, pots of gold, rainbows, more green, etc. *(Commercial Vehicles included!)*
10. Music. Music on your unit is encouraged! Note it in the description to help with placement of your unit!
11. Commercial Entries. Commercial advertising should be done tastefully & in theme with the Parade. **ALL Vehicles must be decorated in theme!** (See #9 above.)

SAFETY

1. Units are not allowed to stop & perform anywhere along the parade route. Units must insure they are keeping pace with the unit ahead of them as directed by Parade Officials & there are no unreasonable gaps!
2. Move in a forward direction only. "Drill" actions are not permitted. Do not stop along the route. Disabled entries should move to the side of the pavement immediately.
3. Drivers of motor vehicles **MUST** remain with the vehicle at all times; including prior to the start of the parade.
4. Alcohol is NOT allowed.
5. Use Caution Around Animal Groups! Waving pompoms & other objects, sudden movements, loud & strange noises may startle horses, which can result in injuries to the rider, the horse,

spectators, or YOU. Anything taller than a horse tends to scare the horse too.

6. Discharging of firearms containing blank or live ammunition & other loud noises is not allowed without prior knowledge & consent of the Parade Committee.

7. Access to staging area is limited to participants and driver only. Participants must be dropped off at the perimeter and walk into their assigned area. Parking within the staging area is limited to the entry only.

LIABILITY

Liability: In consideration of the acceptance of the right to participate in the St. Patrick's Day Parade, by execution of this Entry Form & Rules, I, my organization & all participants (hereinafter referred to collectively as ENTRANT) hereby release & discharge O'Donnell & O'Donnell, LLP; the St. Patrick's Day Parade Committee, their officers, directors, employees, & representatives; the City of Colorado Springs; all Governmental Agencies whose property and/or personnel are used, & anyone else connected with management of the St. Patrick's Day Parade from any & all known or unknown damages, injuries, losses, judgment and/or claims from any cause whatsoever that may be suffered by an Entrant to his/her person or property. Further, each Entrant and/or each member or participant of the Unit expressly agrees to indemnify & hold harmless O'Donnell & O'Donnell, LLP; the St. Patrick's Day Parade Committee, their directors, employees, representatives & anyone else connected with management or presentation of the St. Patrick's Day Parade, from any & all liability including attorney fees & cost occasioned or resulting from the actions or conduct of Entrant's guests, Entrant's Unit, whether it be motor powered, animal or animal drawn or otherwise, or any participant assisting or cooperating with Entrant, whether at the direction or control of Entrant or not under said control or direction. **Initial** _____

Entry & Advertising Release: In consideration of acceptance of this entry, Entrant agrees to permit the Parade Committee to use Entrant's names and/or photographs, films, or tapes of the unit for publicity, advertising & commercial promoting, before, during & after the event, & gives permission to publish or sell or otherwise dispose of said photographs, films or tapes.

Proof of Insurance: Each Entrant will certify that all authorized vehicles are covered by liability insurance as provided by Colorado law, & will be in full force & effect on the day of the parade. Proof of insurance must be in each vehicle. Equestrian units must submit to the Parade Committee the required Certificate of Insurance.

Non-profit Groups: Non-profit groups must submit a copy of 501C-3 form with Entry.

Parade Units violating any of the rules contained herein may, at the discretion of the St. Patrick's Day Parade Committee, be removed from the Parade, disqualified from Awards, and denied entry into future Parades.

I, as a duly authorized agent & representative of Entrant, hereby acknowledge I have reviewed the rules & regulations which are a prerequisite of participation in the St. Patrick's Day Parade & agree that Entrant & all participants & others assisting or otherwise connected with Entrant's unit will abide by said Rules & Regulations before, during & after the parade.
